# AD400007 - Mayoral Minute No. 558 - Amendment to Local Government Act to allow employees to receive domestic violence provisions F19/2132

We are leaders in local government, and we are leaders at Blacktown City.

And as media reports of recent days continue remind us of the tragic consequences of domestic violence in Australian cities and towns, I want to draw attention to an example of the positive role of local government.

This comes via an Award variation, following an application to the NSW Industrial Relations Commission by the United Services Union.

Credit to the USU, but credit also to Blacktown City Council.

The changes originate in a motion put forward at the Local Government NSW annual conference in October 2019 by Blacktown City and Ryde City Councils. In moving Council's position, Cr Griffiths, our Deputy Mayor, spoke strongly in support of those in need of support.

As she has in other forums. Coming into place this month is an amendment to the Local Government (State) Award 2017 which means people working in local government across NSW are now eligible for paid leave if impacted by family and domestic violence.

People working fulltime in local government will be able to access up to 10 days' paid leave to deal with the effects of, or to escape from, domestic or family violence such as moving house, attending court, looking after children, or seeking medical care. Casual staff will be able to take time away from work for the same purposes, without consequence.

We were the first Council is NSW to provide paid domestic violence leave to our staff. It is timely that other Councils are now following our lead. More than 45,000 people working in local government across NSW are now eligible for paid leave if they are affected by family and domestic violence.

A genuine practical benefit brought about by the leadership of this Council, to be proudly recognised by those who serve here.

# AD400005 - Mayoral Minute No. 560 - Passing of Gordon Blackwell, The Nurragingy Blacksmith 59-1-1/2

It is with regret that I bring to your attention the passing of Mr Gordon Blackwell.

Gordon Blackwell retired in May 2015 after spending 23 years as Council's official blacksmith.

Gordon's retirement marked the end of 68 years of shaping metal, withstanding searing heat and, as it was said at the time; 'forging without fakery'.

Mr Blackwell began his career at Lithgow in 1947 as a 16 year old apprentice blacksmith, and a short time later was heat treating rifles at the Small Arms factory.

For 23 years, he demonstrated his trade at Nurragingy Reserve's Blacksmith Cottage, passing on his skills to trainees and demonstrating the unique magic of steel shaping to thousands of tourists.

Of his time in the blacksmith's trade, he said, there was not a day that he did not enjoy getting out of bed and going to the workshop.

He made special mention of his work at the Blacksmith's Cottage where he said it was an absolute pleasure showing thousands of people the trade.

He said there was no need for him to travel the world as he had the pleasure of meeting people from every country across the world when they visited Nurragingy.

Gordon is also fondly remembered for his years working at Hawkesbury Agricultural College.

Gordon bemoaned the increase of electric tools in his trade and the throwaway society.

He said that if you wanted to find out how good a blacksmith is? Take away his electric tools.

According to Gordon, a good smithy only needs hot steel, the right tools and a good anvil; no grinders, no oxy torches, nothing but muscles, skill and a good anvil.

Gordon died last month at the age of 90. It was my privilege to join members of his family and very wide circle of friends at his funeral at the Richmond Lawn Cemetery. Vale Gordon Blackwell.

# **AD400010 - Mayoral Minute No. 563 - SES Volunteers - Keeping our communities safe** F18/4

Over past few months we all have witnessed amazing selfless acts of courage and devotion to duty by our firefighters, both volunteers and paid members of the Rural Fire Service and New South Wales Fire and Rescue.

And here in this chamber we have paid tribute to them.

But tonight, I would like to pay tribute to the other body of men and women, mostly volunteers, who serve our community in times of natural disaster.

I am speaking, of course, of the SES. The State Emergency Service.... And we are well served in our City by 2 SES units, namely Mount Druitt SES and Blacktown SES.

Mount Druitt SES currently has some 70 members, men and women ranging in age from 17 to 80!

They say adversity brings out the best in people and the same can be said for communities, with a significant number of new members joining our Mount Druitt SES in the last 3 months.

During the bushfires, Mount Druitt SES members assisted the RFS in non-firefighting duties in the New England area, in the Police Information and Enquiry Centre in Sydney, in RFS headquarters in Homebush Bay and at the RFS air base at Wilberforce.

With the fierce storms hitting our region this month, Mount Druitt SES swung into full operations mode responding to more than 200 calls for assistance ranging from over-flowing household gutters, through to flooding and fallen trees.

The Blacktown SES has over 130 volunteers and in a testimony to great community spirit, there is a waiting list of 40 people wanting to join.

Blacktown SES members were involved with the Bushfire information line, door knocking in the Blue Mountains, dangerous tree clearing in Batemans Bay and the Unit Commander was deployed at various times, as Recovery Centre Manager in both Ulladulla and Narooma on the south coast.

Two flood rescue teams from Blacktown SES were deployed to jobs all over Sydney during the recent storms, dealing with multiple flood rescues and evacuations of people and animals.

At the same time, other volunteers from the unit dealt with 330 storm related jobs throughout Blacktown City and parts of the Hawkesbury.

Councillors, we owe a huge debt of gratitude to the many unsung heroes of the SES.

They stand up and protect our communities in the face of the worst nature can throw at our community.

### SUSPENSION OF STANDING ORDERS

### **MOTION** (Cr Griffiths/Cr Collins)

That Standing Orders be suspended so that the matter relating to PS3.1 – CL400010 – Climate Change Petition to Blacktown City Council, be brought forward as a matter of public interest. **CARRIED** (at 7.38pm) 15162

The Mayor then delivered a statement on Climate change

The Mayor said that Climate change is real and Climate scientists tell us that the earth's average surface temperature is increasing. They believe that it is extremely likely that the dominant cause of the increase is human activity – especially the burning of fossil fuels - coal, oil and gas. The burning of fossil fuels - along with changes in land use that remove trees - causes an increase in the concentration of greenhouse gases in the atmosphere – especially carbon dioxide. This is what is known as the 'enhanced greenhouse effect' or 'anthropogenic climate change'

Sea levels are rising, as glaciers and ice sheets melt. The ocean surface is warming. Our earth is warmer and it is drier.

Carbon dioxide is being added to the atmosphere faster than it can be removed by other parts of the carbon cycle. Carbon dioxide is the largest single contributor to human-induced climate change. While other factors contribute to Earth's greenhouse effect, carbon dioxide is the main greenhouse gas that humans can control in the atmosphere.

### Western Sydney

Western Sydney has always been hotter than other parts of Sydney. Western Sydney already experiences 20 very hot days (above 35 degrees) on average every year, and it is predicted that there will be 5 to 10 more very hot days per year by 2039. This trend will be added to by the rapid urban development in Blacktown City. The associated removal of trees and vegetation contributes directly to higher local temperatures. The combined temperature increases from climate change and land-use change can have a negative public health impact, particularly when there are prolonged periods higher maximum and minimum (overnight) temperatures.

We know that heatwaves increase the incidence of illness and death – particularly among older people, and those with a pre-existing medical condition or disability.

### **Emergency declaration**

We are in a state of Climate Change Emergency and I have no hesitation in making this declaration.

### Leadership

Our primary commitments are to address climate change by seeking to reduce emissions in our day-to-day operations and throughout the community, provide refuge from extreme heat for our residents and ensure our planning controls and policies reduce urban heat.

He asked the Council to commit to a 100 per cent renewable electricity for all Council operations by 2025. Because we must lead. Because we can make a difference. Let me be clear, it is vital that we work with our industry partners and the community to ensure a clear understanding is built.

But that is what leaders should do. It must be clear that there will be no fundamental impacts on business or employment. Blacktown City Council has been a leader in urban environmental planning for decades. We are in a strong position to deliver a serious plan at a time when those in Canberra and Macquarie Street are giving us little but uncertainty. We want them to lead and we want them to help us do what we seek to do.

He said that he has a letter already written. A letter to Premier Berejiklian seeking a 1 per cent increase in our Council's permitted annual rates charge. This increase would enable us to immediately increase our use of renewables. To advance our target to be carbon neutral and to show what can be done to combat climate change.

#### Our record

In 2011, Council adopted a Blacktown (Climate change) Action and Adaptation Plan 2011-2015. In July 2018 Council endorsed a policy and strategy response to climate change with a commitment to reduce our operational greenhouse gas emissions and to help our community deal with climate change impacts, especially increasing urban heat.

Blacktown City Council already has a zero-net emissions target by 2030 for its operational electricity, fuel and gas use. Council has a number of community tree planting programs aimed at reducing urban heat and is currently trialling heat reduced pavement reconstruction. Ours was the first council to introduce free electric vehicle charging stations and is increasing its own all electric and hybrid vehicle fleet.

Now we must build on our existing commitments. Our context Councillors, Blacktown City has a population of more than 395,000 and that figure is predicted to reach exceed 500 – perhaps 600 thousand people. We are racing past even the most recent official predictions. Massive residential development has produced a 'furnace of urban heat' with hectares of concrete and asphalt replacing bushland and open fields. The policies and planning controls covering those developments have over the years been taken way from Council. Those planning instruments

have to be updated to ensure that any future developments are sustainable and ensure the reduction of urban heat.

The NSW and Federal governments need to fund the strategies to reduce urban heat impacts in Western Sydney. Without urgent action the urban heat impact on our communities will be catastrophic.

### Our action plan

Blacktown City Council will continue working to reduce the impacts of heat and help the community cope.

In the short and medium term Council will:

- use Council's regular media and marketing communication channels to promote heat safety messages to our community
- continue working with the University of New South Wales to provide an evidence base for designing cooler public spaces
- continue developing a heat refuge network to ensure that vulnerable members of the community can access shelter from extreme heat and heatwaves

There will also be longer term impacts through tree-planting and urban planning. Council was successful in obtaining a \$1 million grant through the NSW Government's Five Million Trees for Greater Sydney Program. We are planting more trees in parks and streets with low canopy cover.

Thanks to funding partnership with NRMA Insurance, we are planting more trees in 10 of our playgrounds. We are also working on further street-planting in a Cool Streets© program. Cool Streets© allows local communities to collaborate on the design of street trees to provide shade, maximise cooling and reduce urban heat. This project even quantifies the potential reductions in the need for air conditioning, which can reduce energy costs.

Under our agreed climate change policy settings, Council is preparing a low carbon development strategy for Blacktown City. This strategy will guide our urban planning to maximise emissions reductions and reduce urban heat. We will do this through further greening, using water in the landscape and building design and materials requirements.

Concluding the Mayor advised that he recognised the speakers and petitioners from November last year and referred to what he had said then, I value your passion and I value your commitment to the vital policy question of climate change. There is a climate change emergency and we must act.

We must act.

Australia must have a strong national policy to reduce greenhouse gas emissions. We must be part of an international program. But the time has long passed to wait for Canberra top catch up. We know what we must do. Tonight, we are making a declaration. A clear, unequivocal statement.

We have taken up the fight. Because we can all make a difference. Local government can lead the way. Just as businesses can. Just as each household in Blacktown can. Just as individuals here and everywhere can. We want to lead. The science is clear. We are in a state of climate emergency requiring a call to arms by all levels of government, industry and our communities. I call on all Councillors to support the recommendation before them in the business paper.

## PS3.1 - CL400010 - Climate Change Petition to Blacktown City Council

# **MOTION** (Cr Griffiths/Cr Collins)

- 1. Declare that we are in a state of climate emergency requiring immediate action by all levels of government.
- 2. Endorse the Responding to climate change policy (P000532.1) update (attachment 1) to include commitments to:
  - a target of 100% renewable electricity for Council operations by 2025
  - an aspirational target of net zero carbon emissions for the community by 2040
  - continuing to encourage other western Sydney councils to join us in working to achieve these targets.
- 3. Continue to update our Responding to climate change strategy annually and report our progress to Council.
- 4. Set aside \$100,000 annually for a climate change emergency fund that we can draw on to implement climate change initiatives not currently funded that respond to our Responding to climate change policy, including offsetting our carbon emissions.
- 5. The Mayor write to the NSW Government requesting that the annual rate cap be increased by 1% to allow councils to start funding initiatives such as increased use of renewables, to accelerate carbon neutrality and adapt to climate change impacts, especially urban heat.

**AN AMENDMENT** moved by Cr JG Diaz and seconded by Cr Camilleri – Adoption of PS3.1 with the amendment to paragraph 1. to read -

1. Declare that we are in a state of climate priority requiring immediate action by all levels of government.

THE AMENDMENT was, on being put to the meeting, declared LOST.

Cr Griffiths, Deputy Mayor, then delivered a statement on climate change.

Cr Griffiths stated that the ladies and gentlemen in the public gallery understand why this motion is important. We know that Western Sydney has always been hotter than other parts of Sydney and we know this trend is becoming more acute. It is stating the bleeding obvious that clearing land and interrupting the natural environment to accommodate Sydney's vast planned growth in the north west growth areas will only add to this trend. We must act.

Mayor Bleasdale has laid the case before you clearly. Now we come to vote.

When we last spoke of climate change in late November we were reeling from bush fires which threatened to engulf most of Australia's Eastern Coast. As we now know, things only got worse. Of course, Australia has experienced terrible fires before, but never for such a prolonged period, and never so many, nor with such ferocity.

Let me share what people in Sydney said when 1,800 residents across NSW were polled by our long-time partners, Micromex Research this month. The message is crystal clear. Concern in our community about climate change is real. The top 4 issues of community concern were: Drought,

Bushfires, Cost of living, and Climate change. 85 per cent of respondents believe they will be affected by climate change.

Most people think it will increase their cost of living, make it harder to find fresh food, and that climate change will impact negatively on the health of their families. I note that the people reported their levels of concern have increased dramatically from 12 months ago. 70 per cent of people want their government to respond with increased investment in renewable energy. 65 per cent want more investment in solar panels. 63 per cent want them to reduce Australia's dependency on fossil fuels.

Our Director of City Living can tell you that this Council has been working on climate-related initiatives since 2001. I'm proud of that and I'm proud that we at this Council have built and built on this work for nearly 20 years now. That we are replacing 12,657 mercury vapour streetlamps with LED – reducing our current electricity consumption by 12.8 per cent. That we are adding more solar generation to Council roofs through a power purchase agreement. We are collaborating with other organisations across Sydney. At a regional level, our Council is working with the Western Sydney Regional Organisation of Councils to implement cooling strategies. We are also collaborating with the councils of Parramatta and Campbelltown to pilot the CoolSeal pavement technology here in our city. This group are the first councils in NSW to trial this product. CoolSeal, which is lighter in colour - like concrete in appearance. Cool Seal is expected to reduce road temperatures up to 5 degrees Celsius at night. Blacktown City Council is also a member of Resilient Sydney, with all 33 Sydney metropolitan Councils.

We are working together to plan ways of dealing with potential shocks, including the impacts of extreme heat, on Sydney's energy, health, transport, housing and water systems. So, let's get on with it.

Concluding, Cr Griffiths said that climate change is real. It is real at the melting polar ice caps and it is real in the burning Amazon rainforest. After the summer we have had, it is very, very real in Australia. People know it, and people want us to act on their concerns. I'm proud of our record at Blacktown City, but I want us to do more. Our residents want us to do more. I commend this motion in the strongest possible terms.

There is no system at the moment where you can send in photos but we could certainly send warnings.

**Cr Bunting:** Thank you but what I see is that at a lot of the times it is hard to catch them because they are in and out of these small shopping centres and people with a disability really need these spots. It is also places like 'No Stopping' as well. People park in 'No Stopping' zones and then just go shopping, etc.

Mayor: Yes, it is a difficult question and a difficult problem.

Chief Executive Officer: Mr Mayor, it may be helpful that we do bring a report back in relation to that because an outcome of that report may be that we write to the Minister responsible asking for them to take action and change certain rules or make provision for people to make complaints in that way.
